<p><b><u>Positive Community Impact</u></b></p> <p><b>Social</b> <i>Bringing people together or creating space that fosters this.</i></p> <p><b>Economic</b> <i>Taxes, supporting local businesses, fostering entrepreneurship, attracting new businesses.</i></p> <p><b>Environmental</b> <i>Honoring water features, cleaner air, energy efficiency or health impacts.</i></p> <p><b>Inclusivity</b> <i>Taking into account a broad range of people (age, abilities, race, religion or more).</i></p>	10
<p><b><u>Demonstrates Smart Growth &amp; Livability Principles</u></b></p> <p><b>Support &amp; Value Existing Communities &amp; Neighborhoods</b> <i>Enhance their unique identity through investments in revitalization of existing buildings; foster thoughtful growth and change through mixed-use development, improving walkability, preservation of open space/creation of green spaces, managed infrastructure expansion. Maintain a human scale of development in line with the community's traditional growth patterns.</i></p> <p><b>Provide Choices in How to Get About</b> <i>Provide infrastructure for safe, reliable and economical means of travel for everyone to access jobs, education, food, medical services and social connections. Provide means to equitably decrease household transportation costs, reduce dependence on fossil fuels, improve our air quality by reducing greenhouse gas emissions, and improve public health and well-being. (Create livable, walkable communities that increase accessibility for people of all ages, whether on foot, bicycle, wheelchair, or in motor vehicles.)</i></p> <p><b>Provide Choices in Places to Live (Location, Design, Price Point)</b> <i>Expand design and price-point choices of where to live for people of all ages, incomes and levels of mobility. <p><b><u>Collaboration &amp; Cooperation</u></b> <i>Creative collaboration/cooperation between or among people or groups; <u>and/or</u> involve the community in planning and implementation to ensure that development retains and enhances the sense of place, traditions, goals, and values of the local community; <u>and/or</u> manage growth locally in the New Hampshire tradition, but work with neighboring towns to achieve common goals and address common problems more effectively.</i></p>	10
