Celebrating its 10 year anniversary, 3S Artspace has become a mainstay for the Seacoast's contemporary arts and entertainment scene. Learn more about how this adaptive reuse project transformed an existing 18,200 sq ft derelict concrete building into a performance space and art gallery and became a catalyst for neighborhood revitalization in downtown Portsmouth.

The Colonial Theatre - Laconia, NH

Hear about this impressive restoration project, the economic development tools that made this \$17 million dollar project possible, and why preserving this arts space was so important for downtown Laconia.*
